

## Contest Rules & Regulations

1. This contest is **open to all Malaysian citizens and non-Malaysian citizens** residing in Malaysia:
  - a. No fee for Malaysian citizens.
  - b. Non-Malaysian citizens must have a Malaysian address and pay an administrative fee of RM15. Proof of payment must be provided to The Organizers (WebWeaver Learning Center)
2. Contest participants must be aged **18 years and above** as of 1st January 2012.
3. Entry into the competition is by email to **webweaver.competition@gmail.com**. Emails must be complete with the following information, otherwise they are disqualified:
  - a. **Full Name of participant**
  - b. **IC/Passport Number of participant**
  - c. **Mobile Phone Number of participant**
  - d. **Email address of participant**
  - e. **Full Mailing Address of participant (Must be in Malaysia)**
4. Closing date for this competition **1st March 2012, Thursday (12 noon - Malaysian Time)**. Entries received after this date and time will be disqualified.
5. Participants may submit a maximum of **3 photographs**.
6. Winners will be chosen on or around **15<sup>th</sup> March 2012**, to the best ability of the organizers. All winners will be notified by mobile message (sms) and/or e-mail.

## **Rules & Regulation on Image Submission & Processing**

1. Photographs to be submitted must not have been previously published in any form.
2. Images captured by cameras can be of any format, using film or digital, in color or black & white.
3. No digital super imposition is allowed. Composite photographs, trick photographs, or any form of digital imaging or image manipulations (Clone, Content aware, etc.) will not be accepted.
4. Only minor photo touch-ups such as cropping, adjustment of brightness and color as well as softening or sharpening of the image are allowed.
5. The contestants must be the original photographers and own the copyright of the photographs submitted. The copyright of the image(s) remains with the photographer.
